From an emergency physician viewpoint, these stories are intriguing and provide a good review of the pathophysiology of unique toxicologic cases. The intended audience is broad, but the narrative slips back to medical jargon, which may be too advanced for the layperson having no medical knowledge. Likewise, experienced emergency physicians and medical toxicologists may find the pathophysiology tedious and quickly move past those sections. Medical students, clinical pharmacists, and resident physicians are more likely the ideal audience for this book.

Medical Toxicology: Antidotes and Anecdotes is a short and interesting read. It keeps the reader engaged in the mystery of each case. The intricacies of the diagnostic process are presented in an entertaining way.
